



Whether you are Senior Profile Form is planning to attend a four-year college, community college, trade school, plan to join the military, or seek employment, we are here to help. For those of you who will be researching and applying to four-year colleges, CVHS now has a near paperless system for processing and submitting student documents to colleges using the Naviance eDocs system. Naviance will communicate with Common App and will be the conduit for applying to colleges, including soliciting teacher and counselor recommendations and sending transcripts. The features in Family Connection provide students (and parents) with an efficient and seamless method to submit and monitor their college information in an effective and timely manner. In August, the counselors will be offering training on how to use Naviance for the college application process. ### THINGS TO REMEMBER (Students)

- + Students who apply on paper or through the college's website must update the application status manually in Naviance.
- + Transcripts must be requested in writing in the counseling office using the TRANSCRIPT REQUEST FORM.
- + You must log in to Naviance regularly to update your application information and check for communication from your counselor, teachers, or colleges.




